Georgian Bay Lighthouses declared "Surplus or a Heritage site."

What about those near us between the French River and Collingwood?

Department of Fisheries & Oceans has declared almost 1,000 lighthouses across Canada, including all of Georgian Bay's major lights, to be 'surplus' to their needs. These iconic lights now face an uncertain future, with either demolition or death by neglect a very real possibility.

The sad truth is that satellite navigation has made many lighthouses surplus to requirements. Of course, lighthouses "give our children and grandchildren a feel for what happened in this place a hundred or two hundred years ago." and draw tourists, who spend money.

To understand what is happening around us I have visited some web sites and highlighted points of interest.

"Rather than continuing to destroy the lighthouses, a more concerted effort must be made to ensure the transfer of responsibility from the Canadian Coast Guard to other interested bodies who will protect these historic structures. Our lighthouses are not only geographical landmarks, they mark a chapter in, and a tangible link to, the story of the creation of this country. So far only two lighthouses on Georgian Bay, Manitoulin Island and the North Channel are protected as Classified sites under Historic Sites and Monuments: the Cove Island tower, and the Griffith Island tower. The lightstations' other buildings, including Cove Island's fog plant, and Griffith's dwelling are not declared heritage buildings. The 1857 Griffith dwelling, one of the earliest buildings in this region of Ontario, sits derelict. Losing these structures is short-sighted and unacceptable.

There are numerous inspiring examples of more far-sighted solutions to the perceived problem. As one American, aware of the situation said: "why do Canadians always see things as problems? Why don't you see their potential?" In the United States, lighthouses are protected heritage structures, and, by becoming successful tourist draws, actually contribute significantly to local economies. They are focuses of community pride. "
