



Fake News Special Report: **Drive for 5 or Scandal on Ice?** Doping Allegations Plague Windsor Law Hockey **By Nicole Corriero**

successful "Drive for Five" by the Windsor Law School hockey team at Law Games was tarnished when the team faced accusations of cheating by The 5 Time Law Games opposing players. Champions were required to display their official "Law Games" bracelets to officials prior to their semi final match against Laval, to prove that they were in fact Law Students at the University of Windsor.

Rumours surrounding the team circulated after the first day of competition, when the Windsor Whalers displayed complete dominance in both of their games, disposing of their opponents by 8-2 and 4-1 margins. At the bar that night, members of the French-speaking law schools speculated that Windsor had recruited "ringers" to compete in place of the actual students. There were also whispers of players taking performance-

enhancing drugs, utilizing hockey sticks with illegal curves, and that their sole female player, Nicole Corriero, was actually a man in disguise.

Why do we need it?




