In 1914, the Komagata Maru, a vessel with 376 immigrants from British India, became the first ship carrying migrants to be turned away by Canada. The consequences were felt throughout the British Empire and still echo to this day. More than a history film, *Continuous Journey* is a provocative, moving and multilayered film essay that interweaves photographs, newsreels, home movies and official documents to unravel a complex and little-known story. The haunting soundtrack was designed by Philip Strong, with music by several Toronto stars - Kiran Ahluwalia, Shahid Ali Khan, Ravi Nainpally, Ben Grossman and Mark Korven.

This film has played at the Bloor Cinema and Camera Bar in Toronto, and we are excited to welcome Mr. Kazimi to answer your questions about this key aspect of the history of Immigration Law in Canada. This will be a great evening!

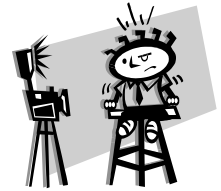
