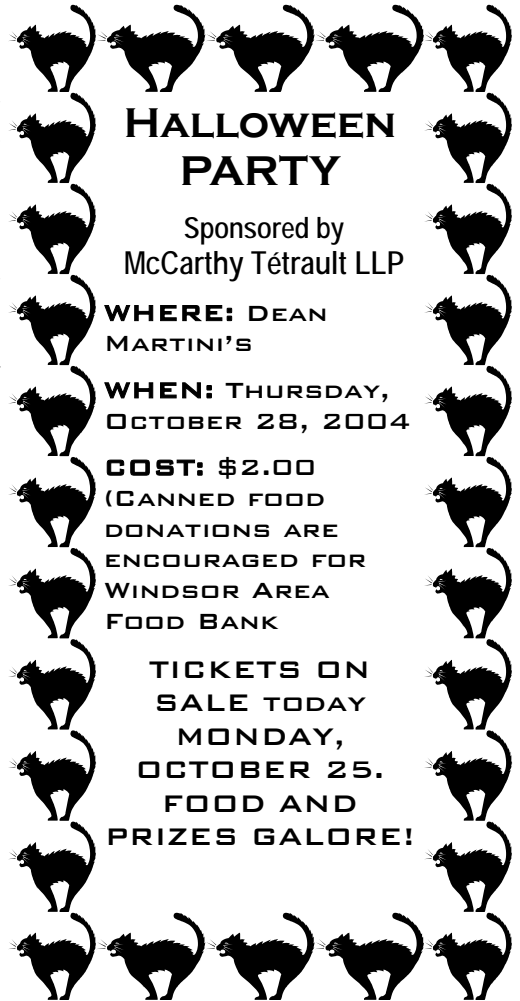

Women and the Law

- (1) Women and the Law invites you to attend an hour-long informal talk with Dina Mazariegos and Victoria Cumes Jochola, members of The Nuestra Voz Women's Collective from Guatemala. They will be speaking in the faculty lounge this Monday October 25 at 4:30 for an hour. ALL ARE WELCOME.

Topics for discussion to include:

- (1) the current situation facing Guatemalans, such as land distribution; (2) violence, discrimination and the exclusion of women in Guatemala; and (3) the impact of the Peace Accords, neoliberalism and globalization on women.

Nuestra Voz was founded by a group of Guatemalan women forced to live in exile in Canada due to the civil war in Guatemala during the 1980s. The Collective was a means for the women to continue the process of solidarity with Guatemalan women they had started at home. In 1993 after living in exile for a number of years, two of the members returned to Guatemala to work with groups of women at the grassroots level, supporting organizational processes through training and accompaniment. Over the years since 1993 the work of the collective has grown to include 10 community groups located throughout the country and a coordinating team that works out of the capital and regularly travels to the member communities.

- (2) Andrée Côté is the Director of Legislation and Law Reform at NAWL (National Association of Women and the Law) and she will be speaking for a 'Women and the Law' event at the law school on **October 27th at 4pm** in the **Faculty Lounge**. She will address the following issues: Pay Equity, Maternity Benefits, Sharia and Family Law.

Monday November 8 at 7:00 in the Moot Court: Panel Discussion on Music and the Internet: "Rocking in the Not So Free Virtual World"

The evolution of the Internet has resulted in the proliferation of music downloading and file sharing. The ability to share music files and create compact discs containing copyrighted material has in turn left the music industry searching for answers to this dilemma. One possible alternative involves litigation against those who infringe on copyrighted material. Other possibilities include the creation of new business models for the distribution of music and other content as a response to these technical advancements. This panel discussion will highlight the challenges presented to the music industry and potential solutions from the perspective of the consumer, recording artist, and legal professional. The legal and economic ramifications of music downloading will also be discussed in order to provide the audience with the foundation of the current law and an insight into how the law will change.
