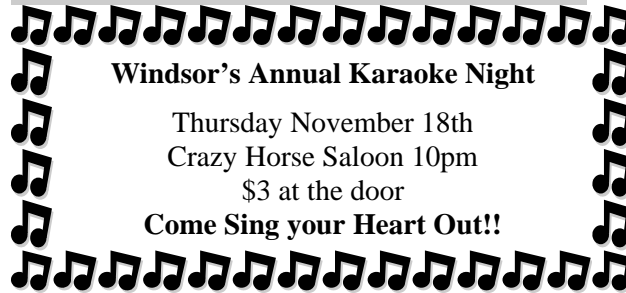

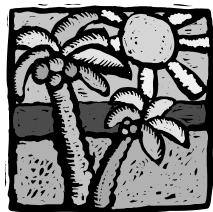
### LEGAL ASSISTANCE OF WINDSOR

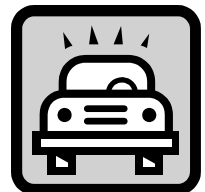
